ONLINE REGISTRATION TOOL

Community Health Vote has an Online Registration Tool that will help you fill out a voter registration form and print it out to submit to your local elections office. Visit www.communityhealthvote.net to enter your information.

BEFORE GETTING STARTED

Training Requirement: Alabama does not require organizations or individuals running voter registration drives to participate in training.

Notification and Registration Requirements: Alabama law does not require civic organizations, employees, or volunteers conducting voter registration drives to provide notification to the secretary of state's office or the county recorder's office of their registration drive.

Compensation Restrictions: Alabama does not regulate the basis by which third-party voter registration organizations pay their employees, but it is best not to pay employees by how many registrations they complete.

OBTAINING APPLICATIONS

State Form: Voter registration forms are available at the secretary of state's website. The secretary of state's office and the county boards of registrars must make voter registration forms available for use in registration drives. There is no limit on the number of forms that may be obtained.

Federal Form: The federal mail-in voter registration application may be used in voter registration drives. It can also be found at http://www.eac.gov/voter_resources/register_to_vote.aspx

Photocopying Blank Forms: Blank forms may be photocopied for use in registration drives.

HANDLING APPLICATIONS

Incomplete Applications: : If you assisted an applicant in completing the registration form by signing the applicant's name, you must provide your name and address in the appropriate box on the voter registration form.

Photocopying Completed Applications: Not permitted prior to returning to county board of registrars, but may be requested afterwards.

HANDLING APPLICATIONS CONT.

Submitting Completed Applications: Completed voter registration forms must be received by the appropriate county board of registrars or postmarked 11 days before Election Day.

Participants in voter registration drives are encouraged to submit completed applications within a week of receiving them.
